SUPREME AWARDS

COLUMBIAN AWARD – This award recognizes excellence in your council’s programming and charitable outreach. To earn this award your council must conduct and report programs in each of the four program categories (Faith, Family, Community, and Life). Requirements for this Award are:

- Conduct the required number of programs in each program area (4 each, for a total of 16)
- Submit Columbian Award Application (Form SP7) (due June 30, 2026)

FATHER MCGIVNEY AWARD – The Supreme Council recognizes those Councils that are growing. New brothers bring new ideas and the manpower needed for your programs. Requirement to get this award is:

- Achieve a 6% new member growth of your council membership (Minimum 5 / Maximum 15)
- All membership transactions must be received, processed, recorded, and released by Supreme by June 30.

FOUNDERS AWARD – The Supreme Council recognizes those Councils that carry on the vision of our Founder Father Michael J. McGivney by promoting the benefits of being a Brother Knight. Requirement for this award is:

- Promote and host two Fraternal Benefit Seminars (virtual or in person)*
*College and military councils are only required to promote and host one Fraternal Benefit Seminar.
- The required sum total attendance of members, or member eligible men, at these events must equal or exceed:
 - 10 for councils with 99 or fewer members
 - 14 for councils with 100 or more members
 - If the GK and DGK meet individually with their agent for a personal review of fraternal benefits available to them, these two meetings will count for one of the two required FBEs (college and military councils excluded).

STAR COUNCIL AWARD – This should be the goal of every Council. The Supreme Council recognizes those Councils that have done an exceptional job throughout the year. Requirements for this award are:

- Meet all the requirements for the Columbian Award
- Meet the requirements for the Father McGivney Award
- Meet the requirements for the Founders Award
- Submit Report of Council Officers (Form #185) (due June 30, 2025)
- Submit Service Program Personnel Report (Form #365) (due June 30, 2025)
- Submit Annual Survey of Fraternal Activity (Form #1728) (due January 31, 2026)
- Be in good standing with the Supreme Council
- Be fully compliant with Safe Environment requirements

MULTIPLE STAR COUNCIL AWARD – The Supreme Council recognizes those Councils that have achieved all of the requirements for STAR Council, and have achieved even higher membership growth with one of these very prestigious awards:

- 200% of their Membership quota – Double STAR Council Award
- 300% of their Membership quota – Triple STAR Council Award

NC STATE DEPUTY AWARD

Each year NC State Council recognizes those Councils that do an exceptional job. This is the highest honor a Council can receive from the NC State Council. It is presented at the NC State Convention every year. To qualify for the State Deputy Award a council must:

Have Council Representation at these Meetings:

- District Mid-Year meeting (January/February)
- NC State Convention (April/May)
- State Regional Council Leaders training sessions (July)
- District Organizational meeting (July/August)

Achieve “Charity” Recognition: For more information and the guidelines, refer to the “Council Recognition Award” below.

State Council Recognition Program: Submit at least four (4) programs to forms@kofenc.org using Form 10784 during reporting period of January 1st to December 31st. For more information and the guidelines, refer to “Council Service Program” section below.

Pay Council Assessments:

- Supreme invoices (Per Capita)
- NC State invoices (Per Capita & Insurance)

Submit the following Supreme Reports:

- Report of Council Officers (Form 185)
- Service Program Personnel (Form 365)
- Semi-Annual Audit covering January-June (Form 1295)
- Annual Survey of Fraternal activity (Form 1728)
- Semi-Annual Audit covering July-December (Form 1295)

Meet or Exceed Supreme Membership Goals: This will be determined by comparison of the Supreme membership reports from January 1 through December 31.

Submit a minimum of three of the following nominations to the State Council for consideration:

- Knight of the Year
- Golden Knight of the Year
- Family of the Year
- Rookie of the Year
- Priest of the Year
- Deacon of the Year

Compliance with Safe Environments: All Council members that are required to complete the required training and/or background check must be verified.

STATE “OF THE YEAR” AWARDS

STATE PRIEST OF THE YEAR AWARD

Each Council is encouraged to submit one (1) candidate for this award. Every Council has that man of Faith that makes an impact on the Council and the Parish. This is an excellent way to give him some special recognition.

A candidate for this award must be a Priest in good standing with his Diocesan Bishop and must have been a member of the Order for a minimum of one (1) year by January 1.

The Priest of the Year should be a Knight who is actively involved in the spiritual growth of the Council and their families, supporting “Faith in Action” initiative, and the vision of our founder, Blessed Michael J. McGivney, while also performing other works within the community.

When submitting your Priest of the Year’s resume, consider the following questions:

1) Does the priest candidate exercise a “pastor’s heart” when ministering to his people?

In Pope Francis’s own words, “mercy must be the cornerstone and bedrock foundation of everything we do in Evangelization.” Provide specific examples.

2) Does the priest candidate place people above ideology? In other words, is he more concerned about doing the right thing or doing things right when exercising his pastoral leadership & spiritual direction? What defines a “practical Catholic.”? Is it all about those who qualify or is it more about standing with the marginalized & disenfranchised?

3) Does the priest candidate have the “apostolic courage” and boldness of faith to stand up and speak out on “quality of life” issues affecting and threatening Christian family values? Is he just a one-note messenger on the pro-life issues of the day: abortion, divorce, and contraception only? Is he equally prophetic about the other pro-life issues impacting the parish family: child immigration, income inequality, gun violence, capital punishment, social justice, human and civil rights, that are all a part of what Fr. McGivney could relate to in his concern to support struggling families?

4) Does the priest candidate exercise a ministry of inclusiveness? Does he practice collegiality, share ministry and collaborate with both men and women across the board?

The local Council’s nominee for the Priest of the Year award need not be the Council’s Chaplain (although this would be unusual). Prior winners of the State Priest of the Year **are not eligible**.

The State Chaplain, with the approval of the State Deputy, will select the winning candidate. The selection process will be concerned with factual information describing the candidate’s accomplishments during the Program Year of January 1 – December 31. The quality of literary embellishments will not influence the decision. The winning candidate will be announced at the North Carolina State Convention and his resume will be read at the banquet.

Please be concise and limit the resume to two (2) typewritten, double spaced, pages. The winning entry will be included in the minutes of the convention, so please use Council letterhead for the first page. To increase the dramatic impact, try to name the candidate only in the last paragraph of the write up.

The candidate's resume must be sent to the State Chaplain, **no later than February 1st**, to be considered. **No exceptions will be considered.** Any questions regarding this award will be addressed to the State Deputy.

The winner will receive free admission to the luncheon and banquet and up to two nights at the host hotel of the State Convention.

STATE DEACON OF THE YEAR AWARD

Each Council is encouraged to submit one (1) candidate for this award. Every Council has that man of Faith that makes an impact on the Council and the Parish. This is an excellent way to give him some special recognition.

A candidate for this award must be a Deacon in good standing with his Diocesan Bishop and must have been a member of the Order for a minimum of one (1) year by January 1.

The Deacon of the Year should be a Knight actively involved in the spiritual growth of the Council and their families, supporting the "Faith in Action" initiative, and the vision of our founder, Fr. Michael J. McGivney, while also performing other works within the community.

When submitting your Deacon of the Year's resume, consider the following questions:

5) Does the deacon candidate exercise a "heart of a servant" when ministering to his people?

In Pope Francis's own words, "mercy must be the cornerstone and bedrock foundation of everything we do in Evangelization." Provide specific examples.

6) Does the deacon candidate place people above ideology? In other words, is he more concerned about doing the right thing or doing things right when exercising his pastoral leadership & spiritual direction? What defines a "practical Catholic."? Is it all about those who qualify or is it more about standing with the marginalized & disenfranchised?

7) Does the deacon candidate exercise a ministry of inclusiveness? Does he practice collegiality, share ministry and collaborate with both men and women across the board?

The accomplishments of the candidate must have taken place during this Program Year (January 1 through December 31).

Prior winners of the State Deacon of the Year **are not eligible.**

The State Chaplain, with the approval of the State Deputy, will select the winning candidate. The selection process will be concerned with factual information describing the candidate's accomplishments during the period specified above. The quality of literary embellishments will not influence the decision. The winning candidate will be announced at the North Carolina State Convention and his resume will be read at the banquet.

Please be concise and limit the resume to two (2) typewritten, double spaced, pages. The winning entry will be included in the minutes of the convention, so please use Council letterhead for the first page. To increase the dramatic impact, try to name the candidate only in the last paragraph of the write up.

The candidate's resume must be sent to the State Chaplain, **no later than February 1st**, to be considered. **No exceptions will be considered.** Any questions regarding this award will be addressed to the State Deputy.

The winner will receive free admission to the luncheon and banquet and up to two nights at the host hotel of the State Convention.

STATE KNIGHT OF THE YEAR AWARD

Each Council can submit one (1) candidate for consideration of this award. Every Council has at least one Brother Knight that stands out. This is an excellent way to give him some special recognition.

A candidate for this award must be a member in good standing and must have been a member of the Order for a minimum of one (1) year by January 1.

The Knight of the Year should be a Knight who is actively involved in the works of the Order, his Church, and his community. All of these areas should be described in detail in his submission. The following percentages will be considered during judging:

- 80% – Work for the Knights of Columbus
- 10% – Work for the Church
- 10% – Work for the Community

The accomplishments of the candidate must have taken place during this Program Year (January 1 through December 31).

The Council's nominee for the State Knight of the Year award need not be the Council's Knight of the Year, although this would be unusual. Nor is it a requirement that the Council's nominee has received the Knight of the Month award, however, that program should provide an excellent pool of candidates.

Prior winners of the State Knight of the Year **are not eligible.**

Judges will be concerned with factual information describing the candidate's accomplishments during the period specified above. The quality of literary embellishments will not influence the decision. The winning candidate will be announced at the North Carolina State Convention and his resume will be read.

Please be concise and limit the resume to two (2) typewritten, double spaced pages. To give enough details on what the candidate has done to deserve this award, the write up should be more than one page long. The winning entry will be included in the minutes of the convention, so please use Council letterhead for the first page. To increase the dramatic impact, try to name the candidate only in the last paragraph to the writeup.

The candidate's resume must be sent to the State Secretary **no later than February 1st** in order to be considered. **No exceptions will be considered.** Any questions regarding this award will be addressed to the State Deputy.

The winner will receive free admission to the luncheon and banquet and up to two nights at the host hotel of the State Convention.

STATE ROOKIE OF THE YEAR AWARD

As a Council recruits new members, often one of these new Brothers seems to get very involved as soon as they join. Each Council can submit one (1) candidate for consideration of this award. This is an excellent way to give that brothersome very special recognition.

A candidate for this award must be a member in good standing and joined the Order no more than eighteen (18) months before January 1.

The Rookie of the Year should be a Knight who is actively involved in the works of the Order, his Church and his community. All of these areas should be described, in detail, in his submission. The following percentages will be considered for each of the areas during judging:

- 80% – Work for the Knights of Columbus
- 10% – Work for the Church
- 10% – Work for the Community

The accomplishments of the candidate must have taken place during this Program Year (January 1 through December 31).

Judges will be concerned with factual information describing the candidate's accomplishments during the period specified above. The quality of literary embellishments will not influence the decision. The winning candidate will be announced at the North Carolina State Convention and his resume will be read.

Please be concise and limit the resume to two (2) typewritten, double spaced pages. To give enough details on what the candidate has done to deserve this award, the write up should be more than one page long. The winning entry will be included in the minutes of the convention, so please use Council letterhead for the first page. To increase the dramatic impact, try to name the candidate only in the last paragraph to the writeup.

The candidate's resume must be sent to the State Secretary **no later than February 1st** in order to be considered. **No exceptions will be considered.** Any questions regarding this award will be addressed to the State Deputy.

The winner will receive free admission to the luncheon and banquet and up to two nights at the host hotel of the State Convention.

STATE GOLDEN KNIGHT OF THE YEAR AWARD

Each Council can submit one (1) candidate for this award. Every Council has at least one Brother Knight that has stood out for many years. This is an excellent way to give him some very special recognition.

A candidate for this award must be a member in good standing and must have been a Knight of Columbus member for at least fifteen (15) years. The Brother Knight so honored should exemplify Columbianism in the truest sense of the word. He should be a true source of inspiration to his Brother Knights. Someone deserving of the title of “**Golden Knight**” should be a man involved in the works of:

- The Order
- His Church
- His Community

His resume should include his involvement and accomplishments in each of these areas.

Judges will be concerned with factual information describing the candidate’s accomplishments. The quality of literary embellishments will not influence the decision. The winning candidate will be announced at the North Carolina State Convention and his resume will be read.

Please be concise and limit the resume to two (2) typewritten, double spaced pages. To give enough details on what the candidate has done to deserve this award, the write up should be more than one page long. The winning entry will be included in the minutes of the convention, so please use Council letterhead for the first page. To increase the dramatic impact, try to name the candidate only in the last paragraph to the writeup.

The candidate’s resume must be sent to the State Secretary **no later than February 1st** in order to be considered. **No exceptions will be considered.** Any questions regarding this award will be addressed to the State Deputy.

The winner will receive free admission to the luncheon and banquet and up to two nights at the host hotel of the State Convention.

STATE FAMILY OF THE YEAR AWARD

Each Council can submit one (1) family for this award. Every Council has at least one family that stands out. Everyone in the family is involved in the Parish and the community. This is an excellent way to give them some real special recognition.

The father of the nominated Family of the Year is not required to be a member of the Knights of Columbus, but councils are encouraged to, at a minimum, invite this man to join the council, as long as he is a practical Catholic in good standing.

To qualify for consideration for the Family of the Year, the candidate for Family of the Year must have been submitted to and approved by Supreme (received on time by the 15th of the following month) within the past calendar year for "Family of the Month". A copy of a Form 10784 for that family as "Family of the Month" must also be in the possession of the State Warden, having been sent to forms@kofcnc.org.

The nomination write-up must include the detailed accomplishments of the entire family. Activities involving the Order should be emphasized, but Church and community activities should also be included and will be considered.

The accomplishments outlined must have taken place during this Program Year (January 1 through December 31). Prior winners of the State Family of the Year award **are not eligible**.

Judges will be concerned with factual information describing the family's accomplishments during the period specified above. The quality of literary embellishment will not influence the decision. The winning family will be announced at the North Carolina State Convention and their resume will be read.

Please be concise and limit the resume to two (2) typewritten, double spaced pages. To give enough details on what the candidate has done to deserve this award, the write up should be more than one page long. The winning entry will be included in the minutes of the convention, so please use Council letterhead for the first page. To increase the dramatic impact, try to name the family only in the last paragraph to the write up.

The family's resume must be sent to the State Secretary **no later than February 1st** in order to be considered. **No exceptions will be considered**. Any questions regarding this award will be addressed to the State Deputy.

The winning family will receive free admission to the luncheon and banquet, ladies and youth programs, and up to two nights at the host hotel of the State Convention.

ANNUAL STATE AWARDS

As members of the Knights of Columbus we are called to do service for our families, our Church and our communities. To help us with our call, the councils organize and run many great programs throughout the year. Through our Building the Domestic Church Initiative, we strive to get everyone in our parishes involved in the programs we organize. We have been doing this for many years. In an effort to recognize the great work already being done, the North Carolina State Council has a number of awards that a Council can receive. Even though you don't do the programs to get awards, it does feel good to get recognized for the work you are doing, and it causes you to want to do even more. With the help of the Council leaders, the Brothers doing the work to make the programs possible will get the recognition they should get. With proper planning these awards can be earned by any Council.

COUNCIL RECOGNITION AWARD

The service programs performed by Councils within North Carolina are judged against a standard defined below based upon the size of the Council. Those Councils that meet the required goals are rewarded. This award is divided into three levels:

- **Charity** is the highest level of performance
- **Unity** is the second highest level of performance
- **Fraternity** is the third highest level of performance

Every Council should strive to reach the Charity level. To achieve the Charity level, it will take a little planning, but is certainly achievable. Will the programs your Council conducted in the past be enough to get you to the Charity level? To be sure, get with your District Deputy at the beginning of the year and go over your program plans with him. Your District Deputy can help you put together a plan that will help you reach the Charity level.

Your plan must include a number of programs in each of these program areas:

- FAITH
- FAMILY
- COMMUNITY
- LIFE

We also recognize that a small Council doesn't have enough manpower to do as many programs as a large Council. Therefore, the North Carolina State Council has divided the Councils into four divisions for the purposes of Council recognition. A breakdown of all Councils by division in North Carolina for the Program Year is provided at the end of this document. The divisions are based on each Council's membership numbers on January 1, 2024, with the inactive and disabled members on the council roster removed.

Reporting Requirements

Reporting for the NC Council Recognition Award is done utilizing the Form 1728. Work with your Council leaders to complete this form and submit it electronically to your District Deputy, State (forms@kofcnc.org), and Supreme. Your District Deputy requires this document to be received by the District Deputy Mid-Year Meeting in early January. This allows for potential corrections prior to the ultimate deadline of January 31. This form is used to determine how many programs were conducted as well as hours and monies donated in each of the four Supreme program areas. In order to ensure that your form is completed in time for the Mid-Year DD Meeting, you should complete it with your District Deputy prior to December 31. Activities planned, but not yet conducted during the reporting period may be counted (For example: The DD and GK should sit down after December 1 to complete the form and if the Council should have a family activity planned for later that month, that activity could be counted in this period.).

The scoring for the Council Program Awards will be as follows: 1 point for every \$10 donated, 1 point for every 10 hours volunteered and 1 point for each visit or activity reported on the Form 1728 in each of the four program categories: Faith, Family, Community, Life. Remember to report your LAMB activities in either the Community or Life categories.

CHARITY DISTRICT AWARD

If all the councils in a given district qualify for the Charity Award, that District Deputy will be presented with the Charity District Award at the State Convention.

LAMB AWARDS

OPERATION Least Amongst My Brethren (LAMB) is one of our greatest outward displays of our Order's Principle of Charity. The people that we support through the efforts of our OPERATION LAMB program have come to rely on your generous donations of time, talent, and treasure. Therefore, the LAMB Foundation of NC, Inc. would like to recognize Councils that go "above and beyond" their assigned goals based on the Council's per member average (total annual collections divided by their beginning of the year membership number) compared to the statewide average of collections.

- A "**Trendsetter Award**" will be given to councils that may not have met their goal, but are still above the per member average for LAMB
- An "**Award of Excellence**" is given to those councils that do exceed their goal
- To recognize the "best of the best" an "**Outstanding Achievement Award**" will be given to Councils that attain the highest per member average in their particular division

These awards are presented at the annual NC State Convention.

MEMBERSHIP AWARDS

Membership is the key to continued success and survival of a Council. New members provide new opportunities for the financial viability of your Council as well as new innovative programs that better serve our families, our Church, and our community. For that reason, the North Carolina State Council recognizes and awards those Councils that are growing in membership.

Council success is determined by total GROSS membership intake from **January 1 through December 31** without taking into account withdrawals, deaths, transfers to other councils, or transfers to the Affiliate Program.

Each goal is based on the Council membership quota set by Supreme on July 1.

Awards will be given for the following achievements:

- 100% of Goal
- 125% of Goal
- 150% and above of Goal
- Highest % of Goal

These awards are presented at the annual NC State Convention.

BEST SERVICE PROGRAM AWARD

Guidelines for Top Program Awards in North Carolina and Supreme

Every Council runs many great programs. Each time a program is completed it needs to be reported on form 10784. All submitted form 10784s for programs completed between January 1st and December 31st will be reviewed for **BEST** programs consideration for his Council in **each** of the four (4) program areas (Faith, Family, Community, Life). It is best if you submit your program report right after the program is completed. The facts for your write-up will be fresh in your mind. A good write-up will have as many facts as possible. All completed 10784 forms will need to be submitted to forms@kofcnc.org to be reviewed and considered. A copy of the submission report is to be sent to your District Deputy and your RDD. The due date is January 15th.

The State Program Directors will select the top 5 programs for his program area in each Division. Emphasis will be given to those programs that are innovative, original, and promote the Order's principles. The winners in each Division for each of the program areas will be awarded at the State Convention.

The State Officers will then review the top winners in each program area and the best program in each program area will be the North Carolina State Program of the Year for that program area. The State will submit the winning programs in **Faith, Family, Community, and Life** to Supreme to be considered for the **Supreme International Service Program Award**.

THE DUANE RUSSELL AWARD – COUNCIL NEWSLETTERS

The Duane Russell Award, presented at the state convention, is given to three (3) Councils that produce the best and consistently good newsletters during the Program Year (January 1 through December 31).

Judging for the Duane Russell Award is based on the following criteria:

- The newsletter must be published at least once per quarter and should include the issue and date of the publication.
- Must be the official publication of the council and for the council members.
- Each issue must include LAMB activities, degree dates, membership activities, and the Family and Knights of the Month.
- **NO** advertising from insurance or financial planning companies that compete with the Knights of Columbus Field Agency should be included.

Style will be judged not on whether the appearance is pleasing to the eye, but if it appears that the newsletter editor attempted to stylize the publication. A copy of the newsletter must be sent to the State Council and the Tar Heel Knight Chairman. The subject line of the e-mail must read as such:

[Issue] Newsletter for [Council Number], [Council Name]

Example: "September 2018 Newsletter for #13812, Pope John Paul II"

COUNCIL WEBSITE AWARD

The Council Website Award, presented at the state convention, is given to three (3) Councils that maintain the best website during the Program Year (January 1 through December 31). This is based on the website content and presentation. The State Webmaster will judge the websites with the following criteria:

Overall:

Websites to be considered must have a link to it on the North Carolina State Website. When using the Knights of Columbus logo, a customized statement should appear “The Official Website of (Council’s name and number) Knights of Columbus” in close proximity of the logo. **NO** advertising from insurance or financial planning companies that compete with the Knights of Columbus Field Agency should be included.

Content Guidelines / Suggestions:

Information should be timely, organized, easy to read and POSITIVE tone.

- Your website should be used to comment on your Council’s progress and encourage participation in upcoming events, as well as public recognition for all awards and recent work well done.
- Family of the Month and Knight of the Month profiles should be a regular feature.
- Operation LAMB and membership progress should be reported.
- Dates of upcoming Degrees should be included.

The following criteria will be used in the judging of the “Council Website Award” of the Year.

The Council Website Award will be awarded to three (3) Councils that maintain the best website during the fraternal year. This is based on the website content and presentation. The State Webmaster will judge the websites.

Points 10 per criteria (Max 100pts):

- Easy to read? (10pts)
 - Is the site able to be navigated without prior knowledge of the site?
 - Is the message readable?
- Does the site include Public Relations and Event information about the programs and events? (10pts)
- Calendar(10pts)
 - Does the site include information members are needing to know?
 - Is this updated?
- Family of the Month/ Year? (10pts)
 - Does the site include information about the Family of the Month/ Year?
 - Is this updated?
- Op. LAMB? (10pts)
 - Is this on the page?
 - Does the site have a redirect to the State Op. LAMB page?
- Membership resources? (10pts)
 - Does the site have resources as to who and how to contact the Membership Director?
 - Forms or a link to Join?
- Online Payments? (10pts)
 - Can a member pay dues online?
 - Can you purchase tickets/ meals online?
- Contact Page? (10pts)
 - Is there a contact page?
 - Does this have a way to send email to the leadership?

- Are there multiple people who can receive emails?
- Links (Max 20pts)
 - State - kofcnc.org
 - Supreme – kofc.org

Remember, what seems like satire to one, may be offensive to others. Choose your words like a true journalist and Knight. All websites that have links on the North Carolina State Council Website on February 1st will be judged. To have your site linked, e-mail the necessary information to the State Webmaster web@kofcnc.org .

KEEP CHRIST IN CHRISTMAS POSTER CONTEST (FAMILY PROGRAM)

The Keep Christ in Christmas (KCIC) program will run annually, following the rules of the Supreme Council as outlined on their website, regarding both subject and content. Each poster must reflect the Keep Christ in Christmas theme with a visual image. There is no limit to the number of posters each contestant may submit. The timeline is as follows.

Local — Councils should order their kits in September or October to be ready to present the contest by November. Posters should be completed by December 1, and the council judging should take place by December 31.

Judging teams should be composed of students, Knights, teachers, administrators, council chaplain, pastor, etc. A 100-point scoring system will be used to determine the winners.

- Slogan — 30 Points:
 - How clearly is the theme presented?
- Visuals — 30 Points:
 - How well do the visuals convey the message?
- Overall Impact — 40 points:
 - How effective was the poster in capturing your attention and causing you to reflect on the topic at hand?

Judging deadlines are as follows:

- District — January 15
- Regional — January 31
- Jurisdictional — February 15
- International — State councils must submit their winning entries to the Supreme Council no later than February 28. International winners will be announced approximately March 15.

Contest entrants compete in one of the grade groups: Kindergarten, 1st through 2nd, 3rd through 4th, 5th through 6th, 7th through 8th. Each local, district, regional or jurisdictional competition may have up to 3 winning entries - a first, second, and third place winner in each grade category.

It is recommended that each participant is recognized by presenting a participation certificate to all who submit entries and council champion certificates to your council's winners. (Certificate is included in KCIC kit from Supreme) Encourage each parish or participating school to develop some type of recognition for the winning artists in that particular school. It is also important to recognize District and Regional winners with a certificate. The State winner will receive proper recognition within the Council's area with a plaque awarded to the individual participant at a time that is agreed upon by the State Deputy.

ESSAY CONTEST (COMMUNITY PROGRAM)

The Catholic Citizenship Essay Contest is to involve young Catholics in 8th through 12th grade (public, private, parochial or home schools) in civic discourse and instill in them religious and life-affirming values. The essay should be approximately 500-750 words on a specific subject, changing every other year. Entrants will be judged on grammar, style, and how clearly they present the theme – which should showcase creativity, imagination and overall development of the topic.

Essays must reflect the assigned theme and be the student's original work. Essays must be typed and be between 500 and 750 words in length. The student's name should appear only on the official Catholic Citizenship Essay Contest entry form, which must be stapled to the essay. All entries become the property of the Knights of Columbus and will not be returned.

The timeline for this event is as follows:

- September: Students write essay.
- October: Judges review essay for council level.
- November/December: Judges review essay at the district and jurisdiction level.
- January: Jurisdiction judging.
- Essays due to the Supreme Council for international judging by January 31.
- Jurisdiction winners should be recognized at the jurisdiction convention or another jurisdiction event.
- March: International Essay Contest winners announced by the Supreme Council office.

Judges (three or more) will be selected by the sponsoring Knights of Columbus council, assembly or circle. Council and/or assembly members, teachers, clergy, civil officials and/or members of the community may serve as judges. The final winner will be determined by the State Officers, or a committee of three (3) selected by the State Deputy.

Essays will be judged on a 100-point scoring system:

- 35 points: Content How clearly is the theme presented?
- 30 points: Grammar Does the essay reflect proper sentence and paragraph structure and utilize correct spelling?
- 35 points: Style Does the essay show creativity, imagination and development of the topic in a compelling style?

It is recommended, but not required, that councils consider monetary awards (\$25-\$50) in the form of gift certificates or cash to first place winners. District and Regional winners should be awarded a Certificate within the District and Regional area as determined by the District Deputy and Regional District Deputy. State winners will be awarded a plaque given by a State Officer, which may be assigned by the State Deputy.

RESOLUTIONS

Resolutions for the State Convention are due to the State Advocate by no later than February 1. **All such resolutions should be submitted in good faith and in a spirit of charity, unity, and fraternity.** As you prepare your resolutions, please bear in mind the principles and procedures set forth below.

Resolutions must fall into one of the following categories and must deal with matters pertaining to the Third Degree:

1. Express gratitude or support for a person, a fraternal program, or a policy of the Order;
2. Amend the North Carolina By-Laws;
3. Submit nominations for State Warden; and
4. Offer proposals to enhance the Order's fraternal mission.

Councils should not submit resolutions that: (1) concern monetary expenditures by the State Council, such as financial grants to organizations; (2) deal exclusively with matters of local significance that are relevant only to that particular council; (3) recognize, commend, denounce, or criticize individual persons or other organizations; (4) propose changes to administrative policies, functions, or procedures of the State or Supreme Council; or (5) have been rejected by delegates to the State Convention in recent years.

Resolutions that do not conform to these expectations and purposes may be deemed out of order, in which case they would not be published to the state website and would not be considered by the delegates.

Delegates to the State Convention may consider only those resolutions that have been officially adopted by a local council or submitted by the State Officers. Resolutions that have not been voted on and approved by the local council should not be submitted to the State Council. "Adoption" of a resolution by a local council means that the program, policy, or sentiment expressed in the resolution has the support of a majority of the voting members at a local council meeting, subject to that council's quora requirements. By adopting a resolution and submitting it to the State Council the local council is effectively stating that it supports the resolution and recommends adoption by the State Council.

Resolutions adopted by a local council for consideration at the State Convention, must be submitted to the **State Advocate** no later than February 1. Please submit these resolutions by email using the following email address: stateadvocate@kofcnc.org.

Resolutions received by the State Advocate will be acknowledged via email and reviewed by the State Officers. Once the resolutions are reviewed and deemed appropriate for consideration by the delegates, they will be published to the state website at least three days prior to the start of the State Convention for the delegates to review.. Any resolutions received after February 1 will not be considered by the State Council and will not be presented to the delegates.
